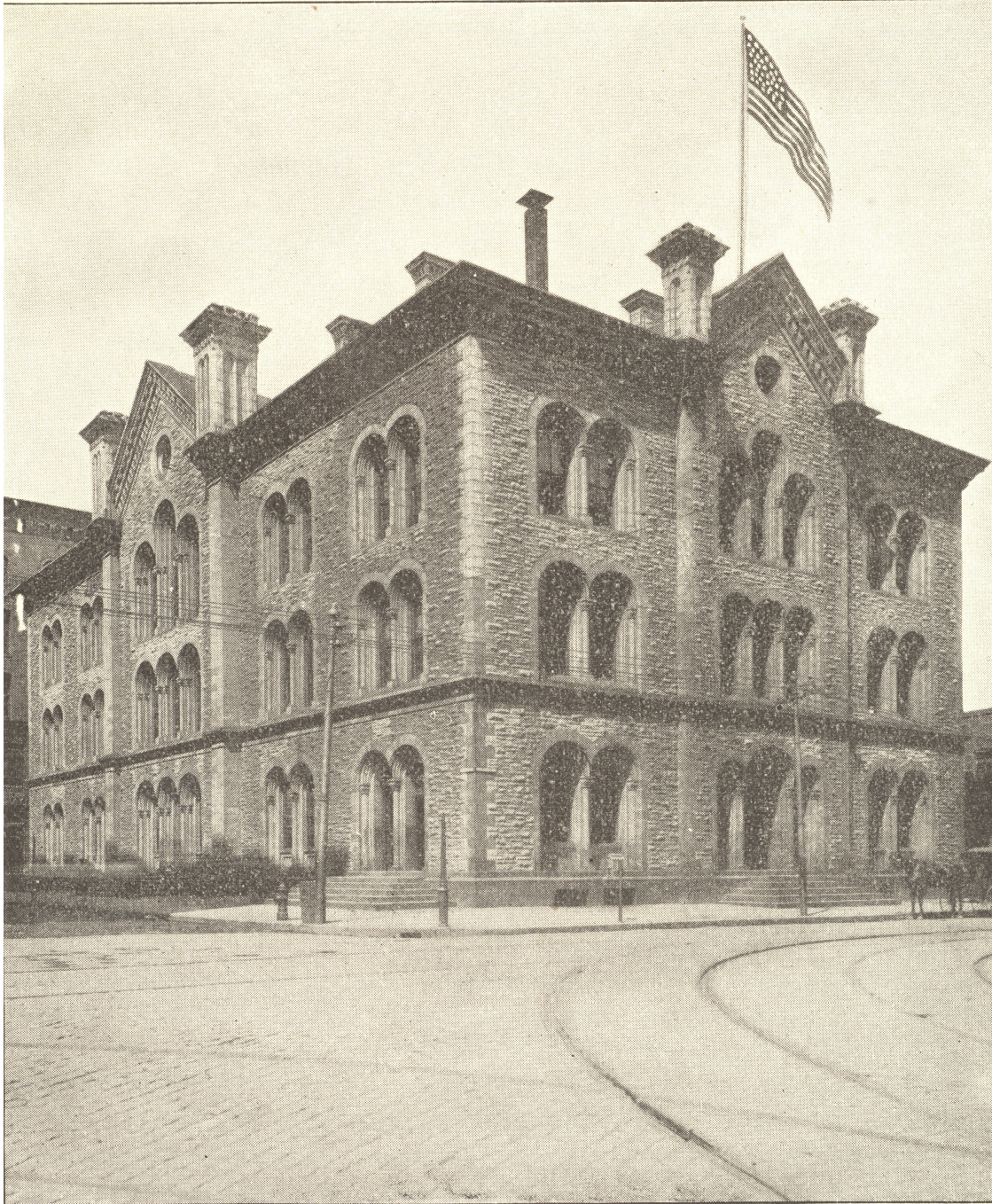

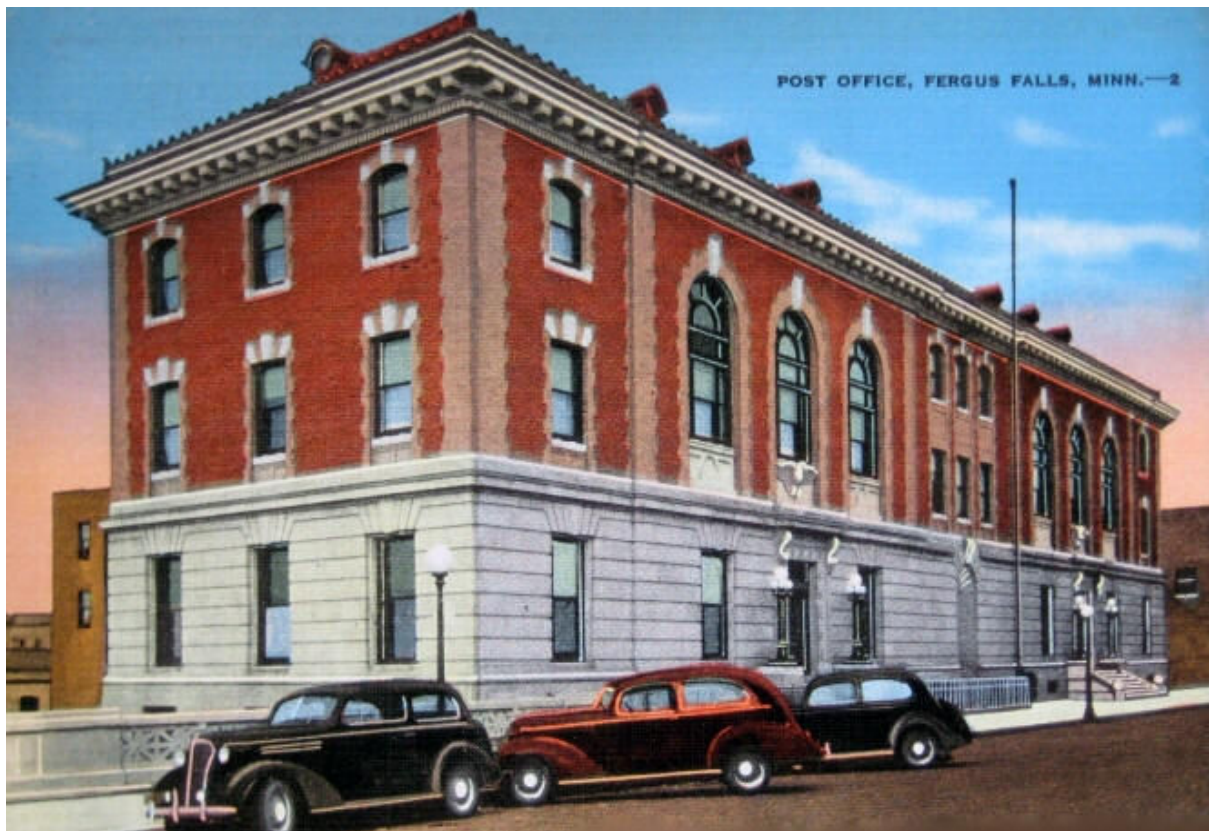

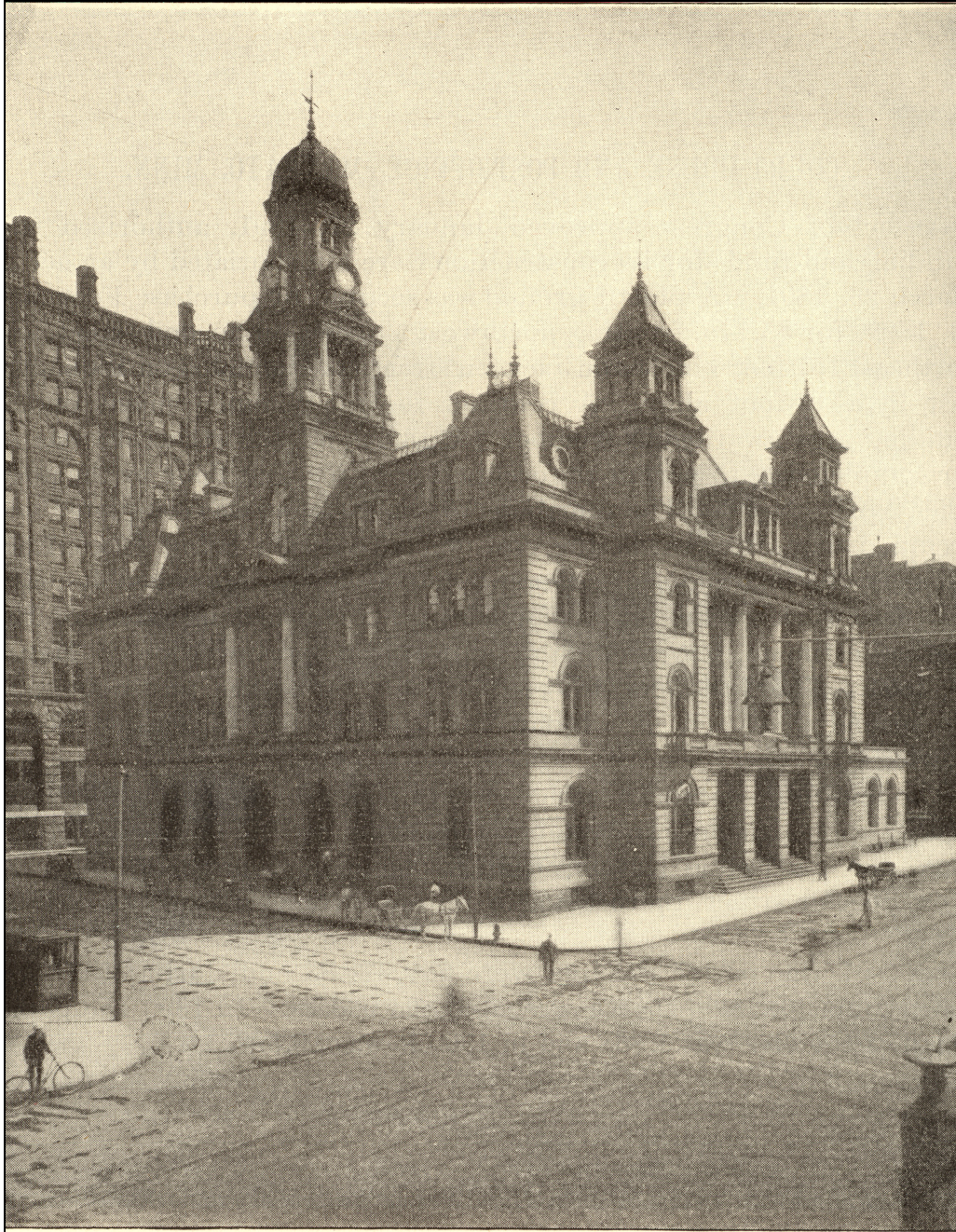

**Completed in 1889, and razed in 1961.**

**Supervising Architect: Mifflin E. Bell**

**Building used by the U.S. District Court for the District of Minnesota beginning in 1890;  
and the U.S. Circuit Court for the District of Minnesota met here from  
1890 until that court was abolished in 1912.**

**Renamed the Federal Office Building and Custom House in 1915.**

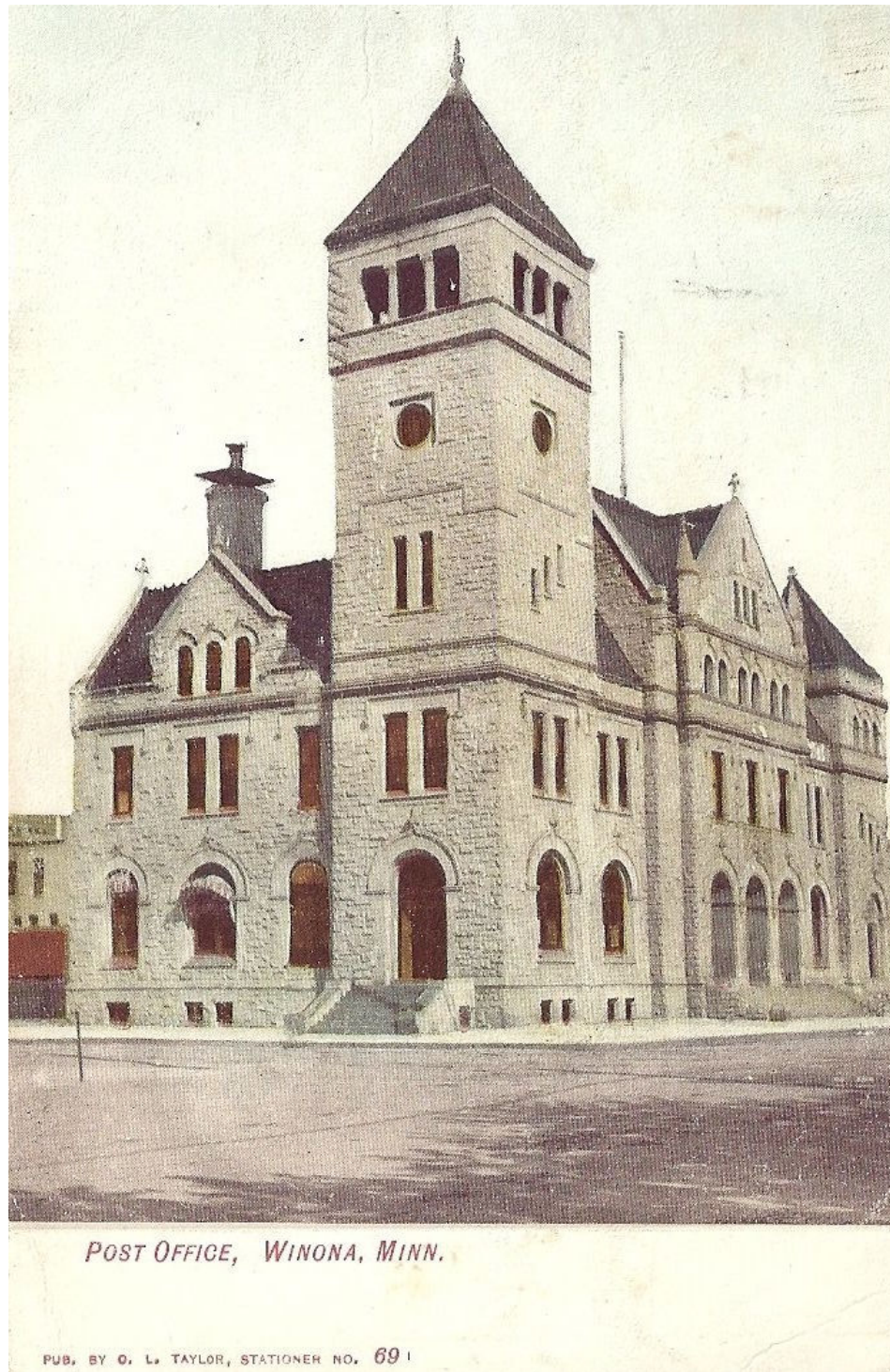
