## **Preface**

There are several thousand photographs in the Minneapolis Newspaper Photograph Collection at the Hennepin County Library. While most were taken in the 1920s, 1930s and 1940s, a few from earlier and later days slipped in. All are in black and white.

There are over 100 photographs of lawyers in the Collection, and several dozen are posted here. It is obvious that many are portraits taken by professional photographers and given to the newspapers for use in articles. Others show lawyers at work. They do not appear in any particular order. The description of each photograph in the Collection lists the name of the lawyer, the date or year of the photograph and sometimes the name of the newspaper where it was published or studio where it was taken. A few have the caption of the photo when it was first published or refer to the event where it was taken. This information is posted below each photo.

The credit for each photograph is to the Hennepin County Library. By making these photographs available without charge to the public, the Hennepin County Library follows the practice and policy of the Library of Congress. It is an important public service.

Volume One of lawyer photographs from this collection was posted on the MLHP in 2017, Volume 2 in 2018 and Volumes 3, 4 and 5 in 2020. Volumes of photos of Hennepin County District Court Judges from this Collection are also posted on the MLHP website.
















